PLANNING:

- 1) LDMP and Welfare Sub-Plan adopted by Council on 15 December 2009. Copies have been circulated and posted on TRC Disaster website.
- 2) LDMG meeting held on 4 March.
- 3) Evacuation and Welfare Committee and Toowoomba Community Recovery Committee meetings held on 2 February and 4 May.
- 4) Information about Evacuation Centres has been posted on TRC Disaster website. Next step is to obtained detail layout plans and sketch suggested layout of Evacuation Centres.
- 5) State Emergency Service Subsidy Program 2010-11 Application submitted for the construction of SES Headquarters at Cecil Plains.

TRAINING (Internal):

SES Executive training weekend to be held on the 19 June.

TRAINING (External):

A number of persons from TRC attended NDRRA information session held at Warrick on 15 December.

Disaster Management Coordinator attended media training course on 15 January.

Disaster management training for TRC District Managers held on 24 February.

Disaster Mangement Coordinator to attend EMA course at the end of July.

OPERATIONS:

Currently investigating alternative accommodation for the DCC.

A public meeting was held at Millmerran on 1 March for the purpose of starting up an SES group. Induction night held on 22 April. Two training nights have been held with a third this Thursday. Eight new personnel have signed up for SES Millmerran Group. New equipment has been ordered. Group well on way to being re-established.

Members from Toowoomba, Clifton and Oakey involved in storm operations in Toowoomba City.

Selected SES Toowoomba Unit members involved in recent floods out west.

EXERCISES: Disaster Management Coordinator attended Dalby Community Recovery Committee Exercise on 10 February. Planning an exercise on 22 July to test the TRC Evacuation and Welfare Management Plan and the Toowoomba community Recovery Plan.

Disaster Management Coordinator attended exercise Erebus held at QPS headquarters on 25 February.

PROJECTED ACTIVITIES: The TRC Evacuation and Welfare Committee is preparing an exercise aimed at demonstrating the roles and tasks in the operation of an Evacuation/Welfare Centre and a Recovery Centre. It is intended to hold the exercise on 22 July 2010 at the Toowoomba Show Grounds or the Oakey Cultural Centre.

DEVELOPMENT PROJECTS:

SES Restructure - All Deputy Local Controllers and Group Leaders have been appointed.

Issue has been raised as to how Council will maintain a disaster response capabilty in the Districts as it moves to a functional structure.

NATURAL DISASTER RISK MANAGEMENT PROJECT ACTIVITIES: (if applicable) Natural Disaster Resilience Program – Funding sought to complete a Natural Hazard Risk Analysis for the TRC area. CONTENTIOUS ISSUES OR MATTERS TO BE RAISED: Paper presented by Bronwyn Herbertson entitled "No One Left Behind: Disaster Management and Evacuation Planning for People with Disabilities in the TRC Region" to Evacuation and Welfare Committee meeting on 2 February 2010.

PURPOSE OF REPORT

To provide Council with an update on various disaster management activities and initiatives in 2009/10.

CORPORATE PLAN REFERENCE

1.4.2 Develop and deliver initiatives to enhance disaster management and preparedness.

BACKGROUND

In 2009, Council established the position of the Disaster Management Coordinator/SES Local Controller in response to disaster events throughout Australia and following the change in emphasis at State and Federal levels in disaster management.

With the appointment of this position, TRC disaster elements and plans have been reviewed and re-organised where required.

ISSUES AND RESPONSE

Local Disaster Management Group (LDMG)

The TRC LDMG is established and functions under the requirements of the *Disaster Management Act 2003*. The group comprises a cross-section of TRC personnel who manage critical resources and representatives from other emergency services agencies. The membership of the TRC LDMG as at June 2010 is detailed in the table below.

During 2009/2010 the LDMG met on two occasions. The LDMG was not activated during the past year.

Local Disaster Management Plan and Evacuation and Welfare Management Plan

In December 2009, Council approved the re-drafting of the TRC Local Disaster Management Plan and Evacuation and Welfare Management Plan. The revised plans have been distributed to all members of the Local Disaster Management Group and the Evacuation and Welfare Committee and posted on the TRC Disaster website for public reference.

Disaster Coordination Centre

The TRC Disaster Coordination Centre (DCC) is established to manage the day-to-day operations of any major disaster event that may arise within the TRC area. The DCC provides the LDMG with accurate up to date information that will enable the LDMG to make informed decisions regarding specific disaster situations.

The DCC is currently situated in the shared facility of the HR Training Room, second floor, 543 Ruthven Street, Toowoomba. An alternate location is being researched.

In August 2009, the DCC was activated during "Exercise Miracle" where the staff operated in two shifts during the five hour exercise period. As a result of the exercise the DCC Standing Operating Procedures (SOP) were reviewed and amended.

There are currently 26 TRC staff members from across all departments on the DCC roster. The staff members have been drawn from the Toowoomba offices only to ensure that the Districts are not adversely affected in the staffing of their own local disaster coordination centres and there is no impact on critical operations.

To ensure that the DCC is able to function effectively, selected equipment has been earmarked. Most of the equipment will be transferred from other TRC areas on activation.

Pathway has been approved as the method of managing requests for assistance. Standard questions have been input in Pathway and Information Management Branch are currently undertaking a project to provide a link between Pathway and Dekho for the purpose of providing visual incident reports. Manual systems have been identified and will be employed in the DCC on initial activation and if the electronic system fails.

Further discussions need to be undertaken to confirm the role of the various District offices and the future customer service centre in a disaster situation.

State Emergency Service Units


A series of reviews of all SES aspects were conducted during the year. As a result the 10 SES Units were re-organised into one Unit and 10 Groups. During the reporting period eight of these groups were fully operational with two groups (Millmerran and Cambooya) undergoing further review with the medium term aim to get both groups operational.


Aligned with the re-organisation all SES Executive appointments were opened for selection. Interviews and selection processes were completed for all Deputy Controllers and Group Leaders.


Reviews of the vehicles, equipment, accommodation and facilities were conducted with recommendations being made to improve the effectiveness and efficiency of all Groups. The reviews have led to submissions for funding grants and bids in the TRC budget.

The following graphs display the operational, community, training and administration hours completed by TRC SES volunteers during the past year. A total of 15,407 hours was provided by the SES volunteers during the period 2009/10.

Public Education/Awareness

During 2009/10 the following initiatives were undertaken to increase public awareness and educate the public of disaster management matters. All education projects were supported to some degree by the TRC Corporate Communications and TRC Information Management Branch staff.

TRC Disaster Website - A website dedicated to disaster matters has been established with a link to the main TRC website. This has proven to be a very good outlet for the transfer of disaster information. The website has news, advice on preparation for disasters, plans, links to other emergency agencies, an education area and a link for SES news and information. The website also provides a restricted operational area which is for use by DCC staff, SES Executive staff, supporting agencies and other TRC elements that require emergency information.

TRC Publications - TRC disaster management articles have been placed in TRC newsletters and fliers regarding preparations for potential disaster threats such as fire and storm.

Newspapers, Radio and Television - Corporate Communications staff has assisted in the preparation of news and article releases to the local newspaper, radio interviews have been undertaken and a segment was included on disaster management in the first series of *Council Connections*.

Toowoomba Regional Shows - An SES stand was set up at five shows in the local region (Clifton, Millmerran, Crows Nest, Toowoomba, and Goombungee). This proved worthwhile giving the SES additional exposure with the local communities and receiving a large number of recruitment enquiries and subsequent recruits.

School and Community Presentations - TRC in liaison with EMQ conducted disaster information presentations at schools (primary and secondary) and community groups throughout the year. These proved to be worthwhile in transferring information to public groups.

Mayor's Parade

On the 14 November 2009 (SES week), a Mayoral Parade was conducted for the SES personnel in the EMQ region. The parade was a great success with over 100 SES personnel on parade. The Mayor and Kerry Shine MP presented certificates and medals to SES members. It is intended to hold this parade annually at different locations around the EMQ region.

Disaster Management Budget/Expenditure

For 2009/10, a budget of \$320,316 was allocated for disaster management. A review of disaster management budgets, including adequacy of SES Group budgets, has been undertaken for the 2010/11 financial year. It is intended during the coming financial year that the control of TRC SES Groups expenditure will be achieved centrally.

Immediate Future Objectives

There are four major immediate future objectives for the TRC Disaster Management staff. These are:

- 1. <u>Conduct an Evacuation and Recovery Exercise</u> Documents are currently being prepared to conduct an evacuation and recovery exercise at the Oakey Cultural Centre on Thursday 22 July 2010. The Exercise has been developed by the Toowoomba Regional Council Evacuation and Welfare Committee and the Department of Communities to demonstrate the roles and capabilities of evacuation and recovery agencies located in the Toowoomba Regional Council area.
- 2. <u>Establishment of suitable building for SES Cecil Plains Group</u> Bids have been submitted to the State Government, State Emergency Subsidy program (\$46,417) and TRC (\$15,472) for funding to build suitable accommodation for the SES Cecil Plains Group. The building would be similar in design and size to the current Millmerran SES shed. The intention is to build the complex in the Cecil Plains Council compound; and
- 3. <u>Conduct a local area natural hazard risk assessment (the whole TRC area)</u> Prior to amalgamation some shire Councils conducted natural hazard risk assessments for their local government area, TRC sought and has been granted funding from the Federal and State governments (\$30,000) to conduct an assessment of the whole TRC area, Council's contribution is \$15,000. This program will commence in July 2010.

Fire Warden Review

(FIRE WARDEN)

August 2000

Declared Fire Danger Period and Permits to Light Fire

As an outcome of the review into the Permit to Light Fire system and the role of the Fire Warden the Commissioner QFRS has issued a notification under Section 63 of the Fire and Rescue Service Act 1990 declaring a Fire Danger Period from midnight 29 August 2010 to midnight 2 January 2011. (Attached)

Declaration of a Fire Danger Period across the State means that anyone wanting to light a small fire that is less than 2m in any direction during the Fire Danger Period will need to obtain a Permit to Light Fire from you as their local fire warden. Other categories of existing notifications that allow fires to be lit without a permit remain unchanged. This includes fires lit out-doors in properly prepared fireplaces for the purposes of cooking (or a trench at least 30cm deep) and those applicable to primary producers, including cane growers.

The introduction of a Fire Danger Period compliments the existing situation in many local government areas where councils have adopted local laws under nuisance provisions of the *Local Government Act 2009* that restrict or prohibit the lighting of fires. If your local government has a local law prohibiting the lighting of fires it is expected that you would not issue a permit unless there were particular circumstances that required the use of fire, or the applicant presented you with local government permission when making an application. Please contact your Area Office for assistance if you are unsure whether or not your local government has a local law restricting or prohibiting the lighting of fire in any part of the local government area.

The requirement to obtain a permit for small fires less than 2m in any direction has been introduced to limit the number of fires that get out of control and to reduce demands on QFRS resources during the bushfire season. During the 2009 fire season a number of small fires that did not require a permit were allowed to escape and were a significant cause of bushfires. This new requirement for a permit will provide opportunity for you to assess the circumstances around the lighting and management of the fire and develop appropriate permit conditions or reject the application.

The requirement to obtain a permit for these small fires during the Fire Danger Period may initially result in an increased number of requests for permits to burn however it is important to remember the following.

- Those persons in the rural community who regularly obtain permits to light fire for primary production, hazard mitigation or other commercial purposes will not be affected by the declaration of the Fire Danger Period.
- The use of fire for whatever reason should not be considered an individual's right and requires due
 consideration be given to the environment and to other members of the community, particularly if the
 oppportunity to use fire is to be retained.
- The fire danger period is declared only for that part of the year when the lighting of such fires represents an increased risk of escape and possible threat to the community.
- Those residents who require a small fire to clean up their land before summer have the period January
 to the end of August to carry out that requirement. Fires for this purpose are not appropriate where other
 methods of disposal are provided or available.

Permits to light are not issued for the incineration of house hold waste or other non vegetative matter and such fires may well result in the release of toxic pollutants into the atmosphere. Fire Wardens are not obliged to issue permits for small fires and can adopt a "No small fires during the declared Fire Danger Period" policy if they wish.

An updated brochure 'Lighting Fires in Queensland' is reproduced here. This brochure will be released to the public shortly, setting out the details of how a declared Fire Danger Period impacts on the lighting of a fire and the effects of local laws on the capacity to light a fire.







Fire and Rescue Service Act 1990

NOTIFICATION

Queensland Fire and Rescue Service Brisbane, 30 July 2010

PURSUANT to section 63 of the *Fire and Rescue Service Act 1990* the Commissioner of Fire and Rescue Service notifies as follows:-

Declaration of a Fire Danger Period

- By reason of the potential of increased fire danger existing throughout the State a fire danger period is declared with effect from midnight on the 29th August 2010 until midnight on the 2nd January 2011.
- Accordingly, fires authorised to be lit under clause 1(a) of the Notification in Gazette Number 112 of 2010, may not be lit for the duration of the fire danger period without a Permit to Light Fire Issued by a Fire Warden under section 65 the Fire and Rescue Service Act 1990.

Fire and Rescue Service Act 1990

NOTIFICATION

Queensland Fire and Rescue Service Brisbane, 30 July 2010

PURSUANT to section 63 of the *Fire and Rescue Service Act 1990* the Commissioner of Fire and Rescue Service notifies as follows:-

- 1. Provided that adequate precautions are taken to prevent the spread of fire, and the lighting of the fire conforms with any Local Law defined for a part of the Local Government Area administered by a Local Government in whose jurisdiction it is proposed to light the fire, or the provisions of the Environmental Protection Act 1994, the following fires may be lit without a Permit to Light a Fire being issued by a Fire Warden.
 - a) a fire in which neither the height, width nor the length of the material to be consumed exceeds 2 metres;
 - a fire lit for the purpose of burning the carcass of a beast;
 - a fire lit at a sawmill for the purpose of burning sawdust or other residue resulting from the operations of a sawmill;
 - a fire lit out-doors for the purpose of cooking, if enclosed in a fireplace so constructed as to prevent the escape of fire or any burning material there from.
- During any period of the year and within any part of the State in respect of which the Commissioner has notified that a fire danger period exists, a fire mentioned in clause 1 a), must not be lit without a Permit to Light Fire issued by a Fire Warden
- The owner or occupier of land used for growing Sugar Cane ("cane production land") that is bordered on every side of cane production land may light on the cane production land a fire for the purpose of burning sugar cane, tops or trash provided that —

- a) no burning is conduction between 10 o'clock in the morning and 2 o'clock in the afternoon;
- adequate precautions are taken to prevent the spread of fire;
- the burning takes place in accordance with recognised practice in the sugar cane industry;
 and
- d) in the case of a fire lit for the purpose of burning any residual tops or trash, the residual tops or trash are at least 10 metres from any headland and from all other flammable material;
- e) where an agreement between growers and millers regulates the times when the burning of sugar cane, tops and trash may be carried our on cane production land – subject to paragraph (a) the burning takes place within those times;
- f) where an agreement referred to in paragraph (e) does not apply to the cane production land – subject to paragraph (a), the burning takes place at a time at which, sugar cane, tops or trash is normally burnt in the locality in which the cane production land is situated.
- i. (1) This Notification does not authorize the lighting of a fire in a part of the State during a period in respect of which the Commissioner by delegation has notified throughout that part that, by reason of a fire danger existing in that part, a fire to which this Notification applies must not be lit.
 - (2) A Notification given for the purpose of this clause must –
 - identify the part of the State to which it relates;
 and
 - specify the period for which it has effect; and
 - be given in at least one of the following ways:
 - a. by newspaper;
 - b. by radio;
 - c. by television;
 - by electronic mass media.
- For the purpose of clause (3) (a) of this Notification, the time referred to therein is, to be determined by reference to standard time for the area concerned.
- 6. In this Notification:

"Cane Production Land"; refers to those lands designated as cane production areas in the Sugar Industry Act 1999.

Lighting Fires in Queensland

The *Fire and Rescue Service Act 1990* is the principal legislation that deals with lighting fires in the open in Queensland. The Act provides a systematic approach to the authorised use and control of fire in the open and for fire prevention.

The Fire and Rescue Service Act 1990 makes it illegal to light a fire without a 'Permit to Light Fire' issued by a fire warden. Under nuisance provisions of the Local Government Act 2009 a local government may also have in place a local law restricting or prohibiting the lighting of a fire in part or all of the local government area.

Obtaining a Permit to Light Fire

An application for a 'Permit to Light Fire' is made through your local fire warden. Contact details for fire wardens are available through the Fire Warden Finder on the Rural Fire Service website www.ruralfire.gld.gov.au. An 'Application for a Permit to Light Fire' can also be downloaded from the website. Following receipt of your application the fire warden may impose conditions on a permit to reduce unwanted risk or nuisance to other people, property or to the environment. The fire warden may refuse to issue a permit if they believe that appropriate safety measures cannot be reasonably achieved.

A Notification issued under the *Fire and Rescue Service Act 1990*, does allow certain fires to be lit without the need to obtain a permit, except if the fires are not permitted under a local law or other legislation. If there is a local law in your local government area prohibiting the lighting of fires, a permit will not be issued by the fire warden unless you have obtained the written permission of the local government.

Fire Danger Period

A Fire Danger Period can be declared by the Commissioner of the Queensland Fire and Rescue Service (QFRS) during parts of the year when conditions make the control and management of fires difficult and communities are at increased risk of bushfire. During a Fire Danger Period there are some changes to the requirements for issue of a permit and to those fires that may be exempt. A declared Fire Danger Period is advised through local media and on the Rural Fire Service website www.ruralfire.gld.gov.au

Fires that do not require a Permit

Fires that are exempt from requiring a Permit to Light Fire are:

- Fires that are less than 2 metres in any direction. **Note:** These fires are not exempt during any Fire Danger Period and a permit must be obtained from a fire warden.
- Fires lit outdoors in a properly prepared fire place for the purpose of cooking (e.g. BBQ and camp
 fires). In this instance it is the responsibility of the person lighting or maintaining the fire to ensure
 adequate precautions are taken to prevent the spread of fire.
- Certain fires used by primary producers and for industrial purposes.

Most local governments provide alternative methods (other than fire) for the disposal of vegetation and waste materials such as refuse collections or disposal of green waste at a council recycling centre. Contact your local government for more information.

Breaches

Anyone found responsible for lighting fires without a permit where one was required, can be prosecuted. Prosecution can also occur if a person is found responsible for lighting a fire that breaches local law or the Environmental Protection Act 1994.

Fire Emergencies

If there is a high fire danger in part or all of the State, the Commissioner QFRS may issue a Local Fire Ban restricting certain fires in all or part of the State.

When a Local Fire Ban is issued, no fires may be lit other than those specifically referred to in the Fire Ban Notice and in the circumstances described in the Fire Ban Notice.

The declaration of a State of Fire Emergency imposes similar or increased restrictions and prohibitions on lighting fires to a Local Fire Ban however this carries significantly increased penalties.

Local Fire Bans and a State of Fire Emergency are advised through local media, on the Rural Fire Service website at www.ruralfire.qld.gov.au and on the Fire Ban Information Line on 1800 020 440.

Enquiries

Prior to lighting fires, a check should be made with your local fire warden, rural fire brigade or fire station to establish whether a fire can be lit in your area. Anyone who is unsure of the local laws regarding the lighting and use of fire in their area should contact their local government.

Before lighting any fire you should check if any notice, notification or fire ban applies for the area where the fire is to be lit. These are published on the Rural Fire Service website www.ruralfire.qld.gov.au and the Queensland Fire and Rescue Service website www.fire.qld.gov.au and In the media.

The Rural Fire Service website <u>www.ruralfire.qld.gov.au</u> has information on 'Using Fire Outdoors' where you will find information on a range of topics in connection with the use of fire and the process of applying for a Permit to Light Fire from your local fire warden.

Information and a range of brochures are available from your local Rural Operations area office who can be contacted on the numbers listed here.

Clarification of a fire lit outdoors for the purpose of cooking

A properly prepared fireplace means a fireplace that is constructed of stone, metal or any other non-flammable material so as to contain the perimeter of the fire. Properly prepared fireplaces also include trenches at least 30cm deep, as there have been many queries regarding hangis.

The important thing to remember when advising the public regarding properly prepared fireplaces, is that no matter the construction of the fireplace, in all circumstances is it the responsibility of the person lighting or maintaining the fire to ensure adequate precautions are taken to prevent the spread of fire.

Conditions applicable to camp fires

- . The ground and air space is clear of flammable material sufficient to prevent the escape of the fire.
- The fire and fuel used are the minimum necessary for the purpose and do not occupy an area of more than 1 square metre.
- A person is in attendance at all times while the fire is alight.

South West residents prepare for fire danger period

The Queensland Fire and Rescue Service (QFRS) is advising South West residents that as of next week, strict new rules regarding lighting fires will be enforced due to the declaration of a fire danger period.

QFRS Acting Regional Manager of Rural Operations for the South West Region, Bruce Ehrlich applauded residents wanting to reduce fuel loads on their own properties but warned they must do this by obtaining a permit to light fire, especially in light of the declaration from midnight August 29, 2010 to midnight January 2, 2011 a Fire Danger Period.

"The declaration of the Fire Danger Period means not all fires, regardless of size, can continue to be lit without a permit during the Fire Danger Period," Mr Ehrlich said.

"Some types of fires have previously been notified as exempt from the requirement for a permit and these exemptions continue provided the use of fire is not prohibited by any Local Government Local Law."

"People should contact their Local Government if they need information about whether there is such a local law covering their property".

Mr Ehrlich said residents who were using a fire outdoors for cooking in a BBQ or a camp fire were exempt and did not require a permit but needed to take the utmost care.

"The most important thing for residents to remember is that regardless of the type of the fireplace, in all circumstances is it the responsibility of the person lighting or maintaining the fire to ensure adequate precautions are taken to prevent any escape of the fire."

"Conditions applicable to camp fires include ensuring the ground and air space is clear of flammable material to prevent the escape of the fire, the fire and fuel used are the minimum to conduct the fire and do not occupy an area of more than one square metre" he said.

"In the South West this will be especially relevant to popular camping areas around the Stanthorpe, Warwick, Goomburra and Crows Nest Areas and the Carnarvon and Mt Moffitt areas in the Far South West. But by all means enjoy this great time of year outdoors but remember it's vital that a campfire is built in a way that will contain the fire and that the fire is attended at all times."

In regard to fires lit outdoors for the purpose of cooking, the QFRS advises that a properly prepared fireplace includes; fixed fireplaces in parks and campgrounds, trenches at least 30cm deep in a cleared area and portable barbecues.

"If you need to get a Permit it's a simple process of applying through your fire warden.

Neighbourhood Safer Places

The 2009 Victorian Bushfire Royal Commission interim report recommended that people need a range of options to increase their safety in the event of bushfire.

The Queensland Fire and Rescue Service (QFR5) recommend that all people living in a bushfire prone area have a personal Bushfire Survival Plan (BSP). This document about Neighbourhood Safer Places (NSP) should be read in conjunction with the BSP guidelines.

When a bushfire threatens, whether your decision is to leave early or stay and defend your property, you should use an NSP only in the event that your BSP fails. In other words, an NSP is a place of last resort.

An NSP is a local open space or building where people may gather, as a last resort, to seek shelter from a bushfire. Use of an NSP may be your contingency plan when:

- your BSP has failed
- your plan was to stay but the extent of the fire means that your home cannot withstand the impact of the fire and therefore your home is not a safe place to shelter
- the fire has escalated to an extreme or catastrophic level and voluntary evacuation is your safest option.

The main purpose of an NSP is to provide some level of protection to human life from the effects of a bushfire. Your NSP will not guarantee safety in all circumstances. The following limitations of an NSP need to be considered if you plan to use one as a last resort:

- Firefighters may not be present, in the event that they will be fighting the main fire front elsewhere.
- NSPs do not cater for animals or pets.
- NSPs do not provide meals or amenities.
- NSPs may not provide shelter from the elements, particularly flying embers.

If you are a person with special needs you should give consideration to what assistance you may require at an NSP.

Although QFRS cannot guarantee an immediate presence during a bushfire, every effort will be made to provide support as soon as resources are available.

You should identify the travel time and distance to your identified NSP. You should include this information in your BSP. You should update your plan every year prior to the bushfire season and confirm that your identified NSP has not changed location. You should not drive through fire affected areas to get to your NSP

Click on your local government area to view the designated NSP locations in your area. If there is not an NSP currently identified for your area, continue to monitor this site for updates.

Once you have arrived at your NSP (building), some actions to consider include:

- Continually listen/seek/monitor further information in relation to the fire by whatever means of communication you may have (radio, mobile phone, internet, etc).
- As fire approaches ensure all doors and windows are sealed as best as possible.
- When fire has passed if safe to do so, check for fires and embers outside extinguish if possible.
- Remain vigitant for possible new fire fronts from other directions.

Once you have arrived at your NSP (open space), some actions to consider include:

- Continually listen/seek/monitor further information in relation to the fire by whatever means of communication you may have (radio, mobile phone, internet etc)
- As fire approaches seek protection from radiant heat and embers as best you can. Attempt to cover any exposed skin with blankets/clothing. You should lie flat on the ground during the passage of the fire front.
- Remain vigilant for possible new fire fronts from other directions. Remember to complete your BSP to ensure that you and your family are prepared and know what to do in the event of a bushfire.

Purpose – The LDMG meeting was called in response to the amount of rain received on Sunday night and potential impact of the rain including the overflow of the Dams.

1.0 Meeting Opened:

The Chair, Cr Noel Strohfeld welcomed those present and noted the apologies. He noted that the DCC was set up this morning.

2.0 Weather forecast

A general overview was provided of the recent and weather forecast over the next few days.

3.0 Director Water Services Briefing

Kevin Flanagan provided an overview of the dam situation. Perseverance Dam overflowed on Friday 7 January. Water commenced overflowing from Cooby Dam at 7:30 pm on Sunday 9 January. The Water Services Dams Event Management Room was activated at 5:00pm on 9 January.

As at 8:00am this morning Cooby Dam was 0.55 m over the spillway, Perseverance Dam was 0.84 m over the spillway and Cressbrook Dam was 1.18 metres below the spillway. Kevin Flanagan left the meeting. He called again at about 1:30pm to say water was flowing over the spillway at Cressbrook Dam.

4.0 Agency reports

- Police, QFRS and QAS provided an overview of issues relating to the Christmas/New Year period.
- EMQ provided the following advice on grants and loans.

On Thursday 30 December 2010, the Minister for Police, Corrective Services and Emergency Services approved the following relief measures for Toowoomba Regional Council:

Counter Disaster Operations, Personal Hardship Assistance Scheme, Essential Services Safety and Reconnection, Restoration of Essential Public Assets, Concessional Loans for Small Business, Concessional Loans for Primary Producers, Freight Subsidies for Primary Producers, Grants for Primary Producers and Grants for Small Business.

On Wednesday 5 January 2010, the Minister for Police, Corrective Services and Emergency Services approved Grants for Small Business and Grants for Primary Producers for Toowoomba Regional Council - \$25,000 for clean up and recovery.

5.0 Resupply of Food

During late December food and medication was flown in by helicopter to Cecil Plains and Tummaville. The river level on 28 December was the highest on record.

Cr Strohfeld, Norman Fry and Kevin Wruck visited Cecil Plains, Millmerran and Tummaville on 4 January to talk to Police, SES and the Cecil Plains store owners.

6.0 Activation

Discussion took place as to whether the LDMG should be activated. Malcolm Johnstone-Leek believed the LDMG should have been activated earlier. Kevin Wruck explained that the LDMG was in alert stage. Communication about events were happening between the Mayor, CEO, Cr Strohfeld and Norman Fry.

There seemed to be some confusion between activation on the LDMG and Disaster Coordination Centre. Kevin Wruck explained the different roles.

Kevin Wruck explained that last night the Council A/H calls received 28 call outs 10 referrals.

It was decided to activate the LDMG and place the LDCC on standby. During the meeting a number of calls were received as a result of the heavy rain that commenced falling around the start of the meeting. As a result it was decided to activate both the LDMG and the TRC DCC.

Ken Gouldthorp - General Overview

- Food-drop failed yesterday to Cecil Plains planned to take place this am.
- Clean-up has started; rubbish can be taken out to the Landfill site. Elderly and disabled are to engage help.

- Lockyer Valley has requested portable water.
- Qld. Health confirmed at 8.15am that boiled water alert has been lifted.

Lockyer Valley: The Department of Communities (Toowoomba Office) has advised that they
have now been requested to provide Community Recovery outreach to the Lockyer Valley,
Esk, and Somerset. Outreach teams to Somerset are planned and 16 Lifeline Community
Recovery Workers have been requested.

- Emerging Issues: Food shortages/Fuel shortages/Truck Drivers stuck in the region that cannot move because of cut roads. Need to provide support financial and emotional to them.
- Pittsworth: A meeting of farmers is occurring today in Pittsworth. Lifeline has been requested
 to supply a Lifeline Counsellor as it is expected that they will be angry and distressed and
 department staff are requesting support.
- Gatton & Helidon: We provided food support and blankets to Helidon and Gatton yesterday.
 Four Lifeline Outreach works went to the Gatton evacuation Centre and provided support.
 Stress level of people in the evacuation centre is high and emotional support is required urgently. A team of 10 Lifeline Community Recovery Workers will leave Toowoomba this morning with department staff to provide support and outreach teams for the Lockyer Valley.

- Toowoomba: Food and Fuel Supplies are of concern at present. Businesses are slowly recovering and cleaning up. The LDMG is meeting on a daily basis at 8.00am.

- It is important keep communication open with the LVRC. TRC currently has 3 crews from Greenmount, an Overseer and Senior Engineer assisting with the recovery works in LVRC.
- On going roadworks re restoring access on the Hampton/Esk Road
- Emphasis will be given to controlling of mosquitos, grass cutting, fogging.

Roger Thompson – Qld Police Services

- Temporary Police Station remains open 24 hours at Grantham
- Roger Thompson stepping down thanks Roger
- 3 persons still missing
- Police team coping with the situation in TRC
- 3 crews per shift in Toowoomba. Any spare teams still at Grantham

Michael Patch - QFRS

- Still restricted in getting appliances to where they are required due to limited access to properties
- One outstanding request for assistance as of yesterday
- Focus today at Tara
- Have utilised rural teams for the last 2 weeks
- 15 Stevenson Street Has a request been received by the operations centre for cleaning the house? Kevin to follow up.

Bev Frost – Department of Communities

1.0 Meeting Opened:

The Chair, Cr Noel Stronfeld welcomed those present and noted the apologies.

2.0 Confirmation of Minutes from Previous Meeting:

4.0 General Business:

4.1 Update on Activities

Representatives from each authority provided an update in relation to their activities since the previous meeting. The following key points were noted:

Kevin Wruck - TRC

- The Disaster Control Centre closed on Tuesday, 25 January at 6.00pm. There was a significant reduction in calls, with most callers enquiring about waste collection services;
- During the activation period there were approximately 1200 Pathway requests entered. In addition 700 + offers of assistance and in excess of 6000 calls received;
- The Office of the CEO is preparing a letter setting out the structure of the long term Community Recovery Group. It is expected that the group will meet in the very near future;
- A discussion session with operational staff from the DCC will take place today. A higher level debrief with Council's Executive, will take place in the coming week.

Norman Fry - TRC

- In December 2010 members from the Toowoomba SES Unit completed 1068.5 operational hours (254 tasks);
- In January 2011 members from the Toowoomba SES Unit completed 3740 operational hours (233 tasks);
- Operational deployments are continuing with the major task, a ground search, currently being undertaken in the Grantham area;
- During the period 27 Dec 14 Jan there were 501 tasks referred to TRC SES groups via the SES 132 500 number.

Tony Shadwell - TRC

- Flood waste collection services continue in Oakey. The free dumping period in Toowoomba has concluded;
- Number of waste collections in Toowoomba was 360.
- Mosquito levels continue to be monitored and managed appropriately, in conjunction with Queensland Health;
- The Environment and Health Branch are providing advice to a number of food businesses reopening after the flood;
- Tony will assist Derek Tuffield with the disposal of unusable donated items.

Derek Tuffield - Lifeline

- Lifeline are presently providing community recovery support across three local government areas;
- Demand for assistance with food supplies remains high, with approximately 50 families requiring support in this region;
- There are significant logistical difficulties being experienced due to the overwhelming quantity of goods being donated and delivered to the area, with approx 7 tonnes being received on the weekend;
- 100 new fridges have been donated;
- There are concerns regarding the possible impacts of the cyclone developing in North Queensland.

Michael Patch - Queensland Fire and Rescue Service (QFRS)

- The Rural Fire Brigade and Blaze-Aid have been working with rural landowners to epair damaged fencing;
- Blaze-Aid consists of volunteers from across Australia and 15 volunteers from the United States of America;
- QERS have been attending to grass fires in the region;

Marisol Alamos - Telstra

- Telstra continues to focus on the restoration of infrastructure:
- A temporary communications site with internet access etc. has been established at Murphy's Creek.

Ged Brennan - TRC

- Access to most residential properties in the region has been restored;
- TRC is working on restoring roads on the bus network;
- TRC has been assessing and documenting infrastructure damage and associated costs.
 There is in the order of 1000 sites with significant damage, with ongoing work expected in the recovery phase;

- Two lanes are open on the up section of the Toowoomba Range, with one lane open on the down section. It is expected repairs on the down section will continue until the end of April;
- Murphy's Creek Road is open and is an alternate route for vehicles;
- TRC is assessing the stability of drainage structures in the region and work has commenced in Bridge Street. Jellicoe Street bridge remains closed due to significant damage. Work is continuing on a priority basis;
- Work is progressing on Council's NDDRA claim. An independent submission is being prepared for major structures with full approval not expected for 6 months.

Anthony Clark - Queensland Ambulance Service (QAS)

- QAS continues to support operations in the Grantham area;
- There has been an increase in heat stress related injuries, with treatment occurring locally;
- · Getting back to business as usual.

David Fraser - Emergency Management Queensland (EMQ)

- Work is continuing in the Lockyer Valley area;
- The 60 day period for emergent works commenced on Thursday. (This has now been amended to 3 February). Refer to DIP for further details;
- 205 volunteers are working in the Grantham area and work will continue for some time;
- TRC Engineering staff (2 road gangs from Greenmount, Overseer and Engineer) have been providing assistance to the Lockyer Valley Regional Council (LVRC);
- LVRC have convened their Recovery Committee.

Arun Pratap - TRC

Councillors have considered the first of a number of reports on the flood event.
 Reporting on recovery actions and a complete assessment of damage sustained will follow.

Garry Humphries - Dept. of Communities

- Work is continuing in the Lockyer Valley and Goondiwindi regions;
- The facility in tong Street continues to operate, providing the community with advice on the raft of assistance options available to them.

4.2 Meeting of the Reconstruction Authority Committee deferred

Cr. Reter Taylor advised that a meeting of the State's Reconstruction Authority had been deferred owing to the cyclone threat in North Queensland.

Critaylor further advised that various dignitaries had visited the region over the past few weeks, including a visit from the Chair of the Flood Enquiry Commission. It is expected that dealings with the various authorities will continue over the course of their investigations.

4.3 Continuance of Regular LDMG Meetings

Chair, Cr Noel Strohfeld sought the Group's advice regarding the regularity of future meetings of the Local Disaster Management Group. It was agreed that the LDMG would next meet on Thursday 17 February for the purpose of a full debrief.



The Chair, Cr Noel Strohfeld welcomed those present and noted the apologies.

2.0 Confirmation of Minutes from Previous Meeting:

3.0 Business Arising

3.1 Update on Toowoomba Community Recovery Group

Ken Gouldthorp provided an update in relation to the Toowoomba Community Recovery Group. It was noted that:

- The first meeting of the Toowoomba Community Recovery Group will take place in March;
- The group will comprise a small focussed team with representatives from agencies directly involved in recovery efforts;
- The group will provide coordination and local input into the State's Recovery Taskforce.

4.0 General Business:

4.1 LDMG Debrief

Representatives from each authority provided a brief. The following key points were noted:

Steve McInerney - Queensland Fire and Rescue Service

- QFRS will aim to have a representative attend each LDMG meeting. Due to the number of staff on annual leave during the January event, it proved difficult in some cases:
- A number of operational debriefs are ongoing within QFRS and opportunities for improvement have been identified (changes in structure and training, expansion of skilled swift water rescue staff)
- QFRS crews did an outstanding job performing rescues and working in treacherous conditions;
- QFRS raised its level of alert on 20 December 2010 in response to the rain activities at that time.

Glen Maule - Queensland Ambulance Service

- The QAS had to overcome the city being divided between the two creeks and resultant issues with the transportation of patients to hospitals;
- QAS were not always able to have a representative present at the Disaster Coordination Centre, however, attended LDMG meetings where they could;
- QAS expressed mixed feelings regarding the timing of the activation of the DCC;
- There were issues regarding access to patients in the Cecil Plains area, due to limited road access and vehicle limitations. Assistance was sought from Dalby Regional Council and SES crews;
- There is some difficulty in determining coverage areas as the boundaries between the different emergency services do not align with the Local Government boundaries.

David Fraser – Emergency Management Queensland

- David expressed the view that there would have been benefit in activating the DCC earlier;
- There was a delay in diverting the emergency number to the DCC;
- Access to the TRC building (DCC) was an issue at times;
- There was no ability to access the Request for Assistance (RFA) program for the SES within the DGC. This could be linked with the Pathway system to provide a conduit for sharing information and processing requests;
- There are funding opportunities available for mitigating damage to water infrastructure,

Norman Fry - Toowoomba Regional Council

- SES callouts commenced on 1 December with over 500 tasks completed in December/January;
- December there were 254 tasks 1068.5 operational hours mainly relating to requests for sandbagging, roofing rescue and evacuation tasks;
- In January there were 233 tasks 3740 operational hours mainly relating to requests for assistance with searches, sandbagging, roofing and evacuations.
- SES groups were stretched with a number of members on leave. Of the 155 members,
 80 were on hand to assist.
- TRC SES groups responded to callouts outside their area (searching in Grantham and Murphy's Creek areas);
- 13 personnel from TRC SES were deployed to assist in North Queensland;
- Misinformation through some sources (commercial radio, real estate agencies) caused some issues as they were directing people to contact the SES for non-emergency situations;
- Sand bagging took up a lot of valuable time. The solution to move sand bag collection to Kearney Springs car park worked well;

- 120 TRC personnel worked in or in support of the Disaster Coordination Centre in various roles:
- There were 5,447 incoming calls and 824 outgoing calls;
- 1230 tasks were entered into Pathway and referred to the actioning agency;
- The DCC was overwhelmed with the volume of offers of assistance. A separate cell to manage these calls is required;
- Air support in the DCC did not function properly. A new cell in the DCC to deal solely with this function is required;
- SES tasking could be improved. A new cell in the DCC is required;
- The location of the DCC was not ideal.
- The State and Federal Governments have announced an award for personnel who
 participated in a disaster management role or volunteer capacity during the
 storm/flood event.

Malcolm Johnston-Leek- Queensland Health

- There would have been benefit in the LDMG meeting more frequently in Dec/Jan given the conditions;
- The DCC should be on stand-by for activation at any point; (%)
- It would be appropriate for people to be appointed to a specific role during periods of activation. If the appointed person is on annual leave that responsibility would transfer to the acting person;
- There needs to be a separation of responsibilities for the person coordinating the DCC and SES;
- The SES crews did a fantastic job and should be congratulated;
- The isolation of Toowoomba due to the damaged road network was a major concern.

Ken Gouldthorp - Toowoomba Regional Council

- The people aspect of the activation went well. Impressed by the willingness of people to assist;
- The activation was the first for the Toowoomba Regional Council;
- There will be a new approach and location for the DCC following the establishment of the Customer Service Centre in Little Street. The new facility will be well equipped for this purpose
- Ken expressed his concern regarding the establishment of the DCC alongside the Council's main call centre. This may be problematic if a disaster occurs in the immediate area and the building is affected or if telecommunications and internet access are lost. This matter will be further investigated;
- Further to this point, the DCC's reliance on telecommunications and internet for communication purposed may be an issue if these services are unavailable during any future disasters. There should be appropriate processes in place to mitigate this risk and robust back-up systems investigated;
- TRC is not considering implementing a new system for the management of DCC requests as most TRC staff are trained in the use of Pathway;
- The DCC was heavily reliant on the use of specialist IT staff to access and analyse information. This system should be simplified to ensure ready access to information;
- Council is aware of the need to improve the facilities provided for the Toowoomba SES Unit;
- TRC sought the assistance of a specialist media advisor to assist with the overwhelming media interest and to oversee the communication of important messages to the community;
- The coordination of incoming offers of assistance requires better management and will be reviewed. There needs to be a mechanism in place to channel these calls appropriately (separate line to DCC);

- The damage to the rail network will cause extra congestion on the surrounding road network, especially given the increase in local coal production. This matter will be discussed by the Recovery Group;
- Ken expressed his gratitude to all agencies involved throughout the activation period.
 The recent events have provided a platform for learning and improving on the management of future disasters.

Vicki Thompson - ABC Radio

- Vicki thanked authorities for the timely provision of information for emergency broadcasting purposes;
- Media management following the disaster went well. There was an increase in activity from social networking sources;
- Extra resources were flown into Toowoomba to assist with broadcasting duties.

Tim O'Neill - Ergon Energy

- Ergon Energy's network held up remarkably well during the flooding event and power loss was minimal with the exception of some businesses in the CBD and house at Oakey, that were switched off for safety reasons;
- There are significant changes occurring to the management structure within the Toowoomba office;
- Ergon Energy aims to improve upon its communication with the LDMG during future disaster events;
- There was limited access to helicopters during the emergency. Better prioritisation of the customers which they service during an emergency is required;
- Repairs to the network are ongoing;
- Ergon Energy is now on Facebook.

Matt Kelly - Department of Communities

- The Department was activated on 26 December 2010. At the time of the Toowoomba flooding event, many staff were assisting in the western affected region;
- Many staff, some from different government departments, undertook training in Community Recovery;
- The main ipswich communication point was flooded and communications affected. A
 paper based system was used during the emergency;
- A non-government agency forum, hosted by Rob Gordon, was held in Toowoomba recently. The presentation on community recovery was very well received and his services could be used for future presentations;
- There is a need to communicate action plans to the community following any disaster event;
- The coordination and management of volunteers needs to be improved and the safety of volunteers needs to be appropriately managed;
 - The provision of various grants for emergency assistance purposes is ongoing. These grants are in addition to those provided by Centrelink.

Ged Brennan, Engineering Services - Toowoomba Regional Council

- TRC Engineering Services was on standby during the Christmas/New Year period;
- On 10 January traffic congestion caused some issues in responding to requests;
- Road closures were managed well in coordination with the Police Service;
- The overall response in emergency and recovery periods was good;
- TRC needs to further investigate the use of two-way radio for use in emergency situations;
- Skytrans provided an excellent service as the need arose. Spare seats were retained on all flights for emergency purposes;

• There were some breakdowns in communications in some Districts within the TRC. This could be improved upon in the event of future events.

Jason Bradshaw, District Services – Toowoomba Regional Council

- The event was a learning experience for the TRC. Communication issues will be considered;
- The systems in place during an emergency could be refined. The people aspect of the response was good;
- The response by TRC and emergency services (including communication with residents), could be better coordinated in areas outside Toowoomba City;

Tony Shadwell, Environment and Health – Toowoomba Regional Council

- The coordination of waste collection services went well, although there were mixed messages regarding the placement of items for collection (ie. footpath, instead of inside property boundary);
- There were some issues regarding the identification of requests for general clean-up services and those involving sewage discharge.

Marisol Alamos, Telstra

- Services to isolated areas, such as Cecil Plains could be improved;
- Network congestion in the CDB area following the event on 10 January had the communication towers working overtime;
- Telstra has the ability to increase the capacity of those towers during exceptional circumstances;
- Telstra has a number of satellite phones on hand for use during an emergency situation;
- Telstra welcomes any feedback in relation to how they may improve their response during a disaster event.

Derek Tuffield - Lifeline

- The evacuation centre was set up promptly at the Toowoomba Grammar School. A number of agencies provided coordination and support services. Thanks must be extended to the Toowoomba Grammar School staff for their services;
- The recovery centre in Long Street played a vital role in coordination efforts;
- Some members of the African community are only seeking assistance now;
- 3 major agencies have had their funding support reduced, which needs to be addressed by the State/Federal government, if they are to continue to provide important community services;
- Donations are still being received. Some of the donated Items have been sent to North Queensland following the cyclone;
- The demand for material aid has been increasing;
- The extent of persons affected in the Toowoomba area and displaced persons is widespread;
- Corporate generosity has been overwhelming and the Chamber of Commerce has launching an appeal.

Kevin Wruck - Toowoomba Regional Council

- investigations need to be undertaken into an early warning system for Oakey
 township
- Department of Communities were requesting maps identifying homes affected by the floods. Apart from Oakey and along East and West Creek this was difficult to provide as there were so many homes throughout the Region were affected by local flooding. Council officers were on the ground identifying flooded properties.

4.2 Timing of Activation of the Disaster Coordination Centre

The LDMG discussed the timing of the activation of the Disaster Coordination Centre in light of views that there would have been benefit in activating the centre prior to 10 January. The group expressed views in favour of both earlier activation and against and the following key points were noted:

- TRC believes it appropriately managed and responded to all situations and requests for assistance prior to the DCC's formal activation on 10 January;
- The physical set-up of the DCC in advance of the activation was beneficial in the circumstances, although there was some difficulty in diverting the SES number. This caused a delay in the ability to receive calls;
- There may have been benefit in more frequent communication between LDMG members prior to 10 January 2011, given the circumstances and lead up to the storm/flood event;
- The DCC should investigate the implementation of varying levels of activation and alert, dependent on the circumstances at the time. (QFRS model)
- Staffing and fatigue may have been an issue if the DCC was activated any earlier.

4.3 Commission of Enquiry/Coronial Inquests

Ken Gouldthorp provided a brief update in relation to the Commission of Enquiry and Coronial Inquests:

- The Commission visited Toowoomba recently;
- It is understood that Toowoomba will be one of the first areas of focus by the Commission;
- TRC has been very active in collating information that may be requested;

4.4 Closing Comments from the Chair

Chair, Cr Noel Stronfeld expressed his gratitude to all involved for their outstanding efforts and services during the emergency response and recovery period.

5.0 Date of Next Meeting:

The next meeting of the Local Disaster Management Group will take place on Thursday, 7 July 2011 in the Mayes Room, City Hall commencing at 9.00 am.
