The Balonne River, St George remains closed for all recreational boating. Only boats authorized by the Queensland Police Service are permitted on the river. The strong current and live electricity lines over the river present a risk to boating.

Balonne River Minor Dirranbandi - The flood level has now reached the March 2010 level of 5.3m. The peak is expected to reach Dirranbandi on Friday 14<sup>th</sup> January 2011, and is expected to be 5.4m. It is expected the level will remain at or above 5m until 27<sup>th</sup> January. High level major flooding is expected to continue in the Balonne River system downstream from St George to the NSW border throughout January. This includes the Bokhara, Culgoa, Balonne Minor and Narran Rivers and Ballandool Creek.

#### Dirranbandi & Hebel

The peak flow will be in the Dirranbandi during Wednesday and in the Hebel area later this week.

#### Thallon - 6am

The Moonie River level at Thallon was at 5.1 metres. Moderate flooding continues to slowly rise further downstream at Fenton where levels are expected to be similar to the 1988 flood peak of about 5.1 metres.

Moderate to major flooding is occurring in the Moonie River between Nindigully and Fenton with the flood peak approaching Fenton.

#### Munaindi

Weir River - Minor to moderate flooding continues to ease on the Weir River between Surrey and Talwood. The flood peak is now in the Jericho area where major river flooding has developed. Senator Joyce advised that there were a lot of watercourses on road and patients would need to be flown.

Steve Mizen mentioned that because of the flooding on the Eastern Seaboard, Mungindi should be evacuated ASAP.

#### **QAS**

John Goudkamp inquired of how to get patients transported to Airstrip at Mungindi and was advised that they would go by QAS vehicle ASAP over bridge prior to the river level rising. Was noted that there were three stretcher patients currently at the Hospital.

# ERGON ENERGY

Brendan noted that Mungindi Qld was supplied by power from Country Energy.

#### **RED CROSS**

Dale Preston inquired where an Evacuation Centre could be set up in Mungindi and was advised that this would be discussed at another Meeting of NDMG Meeting to discuss the possible evacuation of Mungindi Queensland this evening at 6:00pm, when a District Disaster telelink would be set up.

#### **ADF**

Const Shields advised that there was 300m over Ramalis Road and 250m over Daymar Road and this will slow down travel time To Mungindi. Steve Mizen advised that he can't contact the Local SES Controller at Mungindi at the moment, but believes the levee bank is 8.5m.

**BOM** 

Andrew Wyatt (EMQ) advised that he had spoken with the Bureau of Meteorology this afternoon and it advised there would be a peak at Boggabilla of 12m on Thursday. Should have a better idea by 11:00am Wednesday 12<sup>th</sup> January, 2011 for the expected peak at Mungindi, but then it may not know until Saturday or Sunday 15-16<sup>th</sup> January, 2011, if it will experience problems. The Mayor stated that their visit had been very timely as she had received a delegation of residents from the lower end of Alfred Street yesterday afternoon, and she was able to supply them with some answers.

Capt Tobin advised that the ADF had received a fuel resupply yesterday.

4.St George River Water Mr John Carleton advised that there was still a problem with the St George River Water Supply in that the Reservoir was again full of sand and not working correctly. Water restrictions are now again being enforced and notices have been delivered to all St George residents this morning advising that river water is to be used for internal use only. ie

toilets, air conditioners etc. No outside use of river water at all.

Chris Wilson advised that the situation is very hard to fix and as fast as they were filling the water tower, the demand yesterday almost emptied it again. Unable to clean out Reservoir until the river water level drops. They are battling with the rising and falling of the river level. They are also having trouble obtaining another pump, as all pumps are required in other parts of Queensland which have also been flooded.

ADF advised that they could help obtain a filtration system but not a pump.

5.Police Minister Roberts and QPS visit Mayor advised that Balonne had received a visit of the Minister for Police Corrective Services and Emergency Services and Assistant Commissioner for Police Tony Wright. This was a courtesy visit ascertaining what had transpired in so far as the flooding situation, since his last visit recently.

6.SES Boats to across Balonne River

The Meeting noted that the SES Boats would again be commencing ferrying across the Balonne River at 4:00pm this afternoon. Next Tuesday, Thursday and Friday there would be additional ferrying trips across the River taking School Children across.

Debbie Green advised that they had ferried one load of bread across yesterday and would be ferrying 120 crates across tomorrow. These bread ferries were being assisted by members of the Queensland Fire and Rescue Service.

7.Future LDMG Meetings

LDMG Local Disaster Coordinator Scott Norman suggested that following the next peak in the river, the Group would be concentrating on resupply of the Shire, and the Group may revert to holding meetings every second or third day but this will be decided at a future Meeting.

8.Dirranbandi Water Supply

Mr John Carleton advised that the latest result for the testing of the Dirranbandi River Water Supply had come back clear. Only needed one further clear test, and the water would no longer have to be boiled prior to consumption.

Minor Earthquake - Dirranbandi Area

The Courier Mail has reported;

"AN earthquake in central southwest Queensland early this morning has left residents feeling slightly rattled.

At 5:40am (AEST) an earthquake measuring 3.6 on the Richter scale occurred between Dirranbandi and St George, about 500km southwest of Brisbane.

Australian Seismological Centre director Kevin McCue said the earthquake was big enough to do minor non-structural damage to local properties and felt out to a distance of 30km or 40km.

"It wouldn't have been enough to wake people up but anyone who's a light sleeper or awake would have felt a slight rattle," he said. "Local farmers may have had minor cracks in their homes near the epicentre." The earthquake was measured on seismographs as far as northern South Australia."

Mr Kevin McCue has advised Council that there is no cause for alarm. There is no damage to levy banks at Dirranbandi. As a precaution Geoscience Australia, the Australian Government agency responsible for monitoring earthquakes been contacted and they confirmed a small event at that location that was no cause for concern.

The first the LDMG knew of this was a phone call to the Mayor from a Newspaper Group, this morning.

#### St George River Water Restrictions

The St George River Water failed this morning when demand out stripped supply. Demand was very high even for a very hot day and it is reasonable to assume not all people are adhering to the water restrictions, the restrictions will be enforced if people are caught doing the wrong thing.

Level one water restrictions still remain in place, a water tanker remains on standby for fire fighting capacity should supply fail again. A floating submersible pump is in transit to supplement supply and back up the diesel pump that is currently being used. This should be installed over the weekend. Until the floating pump is operational there remains a chance the river water will fail if demand again outstrips supply, the situation is being monitored and more severe restriction may be necessary.

### St George - 10.44am Thursday 27th Jan

At 9pm Wednesday 26<sup>th</sup> January, the Balonne River at St George was 12.04m and falling. The Andrew Nixon Bridge is not expected to be clear for traffic until mid next week. Note: The Bridge will be walked when at .3m and request made for DMR Inspector to inspect at .2m

- There will be a Public Meeting held for the people of Dirranbandi to discuss the preparations prior to being isolated.
- Efforts of those people responsible for the high clearance vehicle access to Dirranbandi was very much appreciated.
- Dirranbandi area had an earthquake which caused concern with the levee banks, but no problems occurred.

Hebel - Suffered similar isolation to Dirranbandi although longer.
