- This statement has been provided without any knowledge of the contents of other . 2 evidence that will or may be adduced, or the submissions that have or will be made to the Commission of Inquiry. I will supplement this statement with addendum statements if it is necessary.
  - I will provide any further information or explanation required by the Commission of 3 Inquiry.

## QUALIFICATIONS, EXPERIENCE AND CURRENT POSITION

## Qualifications and experience

- 4 In 1999 I completed a Bachelor of Civil Engineering from the University of Queensland.
- 5 In about 2000 I commenced work with SunWater Limited (SunWater).
- I left my employment with SunWater to undertake a Masters of IT in 2001, which I 6 completed in 2003. I recommenced employment with SunWater shortly afterwards.

### Current position

- My current position at SunWater is as a Senior Engineer/Hydrologist in the 7 Headworks Design division of SunWater. I have been in this current position for approximately 2 years.
- in addition to my role as a Senior Engineer/Hydrologist, I also worked as a flood 8 officer in the Flood Operations Centre (FOC) during flood events. I started in this role in 2004 and ended this role in mid-2011 when SunWater's contract to provide flood operations services expired.

# DATES AND TIMES PRESENT IN THE FLOOD OPERATIONS CENTRE

9 I worked as a flood officer in the FOC during the January 2011 flood event in the following shifts, with the following flood engineers on shift:

- (a) From about 7pm, Saturday 8 January to 7am, Sunday 9 2011 with John Tibaldi on shift;
- (b) From about 7am to 7pm, Tuesday 11 January 2011 with Terry Malone and John Tibaldi on shift:
- (c) From about 7am to 7pm, Wednesday 12 January 2011 with Terry Malone and John Tibaldi on shift;
- (d) From about 7pm, Friday 14 January to 7am, Saturday 15 January 2011 with John Tibaldi on shift;
- (e) From about 7am to about 2pm on Wednesday 19 January 2011 with Terry Malone on shift.

#### RELEVENT EVENT LOG ENTRIES

- The notice requires me to provide a statement which gives an account of the entries in the flood event log (exhibit 23) that were made by me between 12am 7 January and 12am 12 January on the following topics:
  - (a) The transition from strategy W1 to W2 or W3;
  - (b) The transition to strategy W2;
  - (c) The transition to strategy W3;
  - (d) The transition to strategy W4;
  - (e) The primary consideration in operating the dam and choosing release rates at any time,

(which I have called the "relevant event log entries" for convenience).

- The two shifts that I worked within that period were:
  - (a) 7pm, Saturday 8 January to 7am, Sunday 9 2011; and
  - (b) 7am to 7pm on Tuesday 11 January 2011.
- I did not make any entries in the event log during those shifts, so there are no relevant event log entries for me to provide an account of.

#### **FURTHER INFORMATION ABOUT RELEVANT CONVERSATIONS**

The notice further requires me to provide any further information or details, including accounts, if possible of all conversations (in person or telephone) that I took part in with, or overheard between, the flood operations engineers and/or the

flood officers and/or other persons during the period 7am, 7 January 2011 to 12am, 12 January 2011 in respect to the following topics:

- (a) The transition from strategy W1 to W2 or W3;
- (b) The transition to strategy W2;
- (c) The transition to strategy W3;
- (d) The transition to strategy W4;
- (e) The primary consideration in operating the dam and choosing release rates at any time,
- 14 I cannot recall any conversations during my shifts in relation to those topics.

- 6. Any further information or details, including accounts, if possible, of all conversations (in person or telephone) he took part in with, or overhead between:
