Council endorse and adopt as an interim measure for new buildings requiring approval (le MCU) an interim building height for a minimum habitable floor level of the January 2011 flood event level plus 300mm. This level is to be reviewed when the results of the flood study (currently underway) are available. Existing planning scheme levels will prevail if greater than the January 2011 flood event.
- Owners re-constructing or building a dwelling on land where a dwelling existed prior to the January flood be required to provide an indemnity statement to Council confirming that they are aware the Council has recommended that the minimum habitable floor levels for reconstructing a dwelling on the land be 300mm above the January 2011 flood level and that as owners they are aware of the risks and issues associated with rebuilding at a lower level. Existing planning scheme levels will prevail if greater than the January 2011 flood event. 🗳
- Council investigate the processes to have new flood levels apply to the whole of the Lockyer Valley Regional Council area.
- 4. Council prepare advice for applicants explaining the decision to adopt the interim flood levels ahead of the completion of the flood study and outlining mediation options available for those unhappy with the decision.
