Requirement to Provide Information to Peter Borrows dated 3 February 2012

We refer to the Commission's requirement to provide information dated 3 February 2012 issued to Peter Borrows which requires the following:

- 1. a list of any and all meetings, teleconferences and conversations involving employees of Segwater with:
 - (a) Professor Colin Apelt regarding his review of the January 2011 Flood Event,
 Report on the operation of Somerset Dam and Wivenhoe Dam, dated 2 March
 2011 (Flood Report);
 - (b) Mr Greg Roads regarding his review of the Flood Report;
 - (c) Mr Leonard McDonald regarding his review of the Flood Report; and
 - (d) Mr Brian Shannon regarding his review of the Flood Report,

which includes references to the dates on which the meetings, teleconferences and conversations occurred and the names of people involved in the meetings, teleconferences and conversations; and

2. copies of any and all records of the meetings, teleconferences and conversations referred to on the list

(the Requirement).

In this response, we refer to Professor Apelt and Messrs Roads, McDonald and Shannon collectively as the *Peer Reviewers*.

A preliminary list is provided at Attachment A.

The list has been compiled from:

- the electronic correspondence between the Peer Reviewers and Seqwater regarding the
 review of the Flood Report provided to the Commission on 27 January 2012 in response to
 the information requirement dated 25 January 2012 issued on Peter Borrows (*Borrows Response*); and
- records of meetings contained on the enclosed USB which our client has been able to collate since receipt of the Requirement at 7:54 pm on Friday, 3 February 2012.

The list includes references to the Borrows Response and documents contained on the enclosed USB for the Commission's convenience.

In light of the timeframe for the Requirement, difficulties associated with contacting employees (particularly administrative staff) over the weekend and the fact some employees have separate legal representation in relation to the Commission's hearings, our client is not in a position to confirm whether the list captures all meetings, teleconferences or conversations between its employees and the Peer Reviewers.

Furthermore, our client cannot confirm who was involved in the meetings in every instance as records of attendees were not always kept. The names in the list have been drawn from electronic calendar appointments and reception records as contained on the USB.

Other documentation

Our understanding is that John Tibaldi had principal carriage of responding to technical queries from the Peer Reviewers. We note that Mr Tibaldi has been questioned about this (from T5039).

Notwithstanding Mr Tibaldi's testimony, our client intends to continue its efforts to locate any records of the meetings, teleconferences and conversations listed in Attachment A that have not otherwise been included on the enclosed USB.

Given the difficulties in making complete inquiries over the weekend period, Seqwater submits the attached list and USB in partial fulfilment of the Requirement. Further inquiries will be made on Monday, and Seqwater proposes to provide a further update to the Commission, with any supplemental records identified, by 6.00 pm, Monday 6 February 2012.

To the extent necessary, our client seeks an extension of the time for compliance with the Requirement until 6pm on Monday, 6 February 2012.
