Queensland Floods Commission of Inquiry - State Representation

I refer to my letter dated 21 April 2011, and to the comments made by the Commissioner yesterday requesting I seek instructions on three discreet issues. In relation to those issues, I am instructed as follows:

- 1. That every State employee and member of volunteer services is entitled to receive legal representation by Crown Law. It is entirely a matter for the individual employee or volunteer as to whether they avail themselves of that benefit. Additionally, there are, within each of the agencies concerned, legal departments able to assist individual employees and volunteers in providing information to the Inquiry. As to whether the individual employee or volunteer avails themselves of this assistance, it is entirely a matter for them. Accordingly, we have no objection to the Commission directly approaching any proposed witness for an interview or information. I would ask that Crown Law be advised should this occur. The employee or volunteer would then have the option of having Crown Law present if desired. I do not have, and never had have, any desire to hinder or delay the work of the Commission;
- At the direction of the Premier, all State employees will be advised that every public servant is to assist the Commission of Inquiry in every way possible and provide any information requested. In that regard, a copy of an email message from the Director-General, Department of the Premier and Cabinet is enclosed;

You are free to approach the COI in a personal, as well as a work, capacity. If the COI approaches you, you should co-operate fully.

The legal section of your Department and Crown Law are available to assist you at any time - particularly should you be asked to provide a formal statement or appear at a public hearing of COI.

You should be aware that the COI provides protections to all individuals providing evidence - this includes public servants and volunteers. You should honestly answer all questions relating to those matters within your area of responsibility.

You of course remain free to make any submission and give evidence to the COI in your personal capacity as a private citizen.
